## REQUEST TO REMOVE IDENTIFYING INFORMATION

House Bill 2427, passed in the 2012 legislative session, is directed at protecting home address or home ownership identifying property information of law enforcement officers and certain court personnel. The Johnson County website, <a href="www.jocogov.org">www.jocogov.org</a>, currently provides access to owner and address information together in the <a href="Location Maps and Info">Location Maps and Info</a> section. Upon completion of the information below, ownership information in this section will be blocked from public access. No other public website provides this combined information. Only information for those classes of individuals identified in HB 2427 are eligible to be blocked; spouses and co-owners are not eligible to have their information blocked. Only your property residence will be blocked; rental or investment properties in your name will not be blocked. This bill updates **K.S.A. 45-221.** 

This Request only blocks home ownership identifying information maintained on the County's real estate roll. If you have voluntarily filed or recorded documents containing your home address with any County department or agency, those documents will not be altered by the County and may still be accessed pursuant to the Kansas Open Records Act. If you have specific concerns regarding records on file with a County department or agency, please contact the Johnson County Department of Treasury Taxation & Vehicles at (913) 715.0775. If you would like to request that your residence address be concealed from public inspection on the voter registration list, please contact the Johnson County Election Commissioner at (913) 782.3441.

Identifying information for only the following classes of individuals will be blocked:

Law enforcement officer (as defined in K.S.A. 2011 Supp. 21-5111 and amendments thereto), parole officer, probation officer, court services office, community correctional services officer, federal judge, justice of the supreme court, judge of the court of appeals, district judge, district magistrate judge, United States attorney for the district of Kansas, assistant United States attorney, the attorney general, assistant attorney general, district attorney, assistant district attorney.

Please complete all fields in the request form and submit with your original signature to the Johnson County Treasury, Taxation & Vehicles Department. Incomplete forms or copies will not be processed.
